

2024 Grant Guidelines

GRANT OPPORTUNITIES

TRANSFORMATIONAL GRANTS

- Create meaningful changes in the lives of the people being served.
- Demonstrate shared goals across a continuum of institutions, organizations, and programs.

TRANSFORMATIONAL SHAPING TOMORROW HELPING TODAY ACORN URGENT

SHAPING TOMORROW GRANTS

- Strengthen nonprofit organizations in Erie County that address key community needs.
- Range from \$50,000 to \$250,000.
- Prioritize projects that support marginalized communities and fuel inclusive growth strategies through a collective impact approach.

HELPING TODAY GRANTS

- Reflect input from the community and contribute to advancing the organization's mission.
- Do not exceed \$50,000 and must be used within 12 months.
- Prioritize projects that directly benefit individuals and families who are socio-economically disadvantaged or uplift historically marginalized communities.

ACORN GRANTS

- Provide support to newer and smaller organizations (fewer than five years old or with a budget less than \$150,000) to establish a solid foundation.
- Do not exceed \$10,000.
- Prioritize organizations that identify a need and explain how it is essential to build capacity.

URGENT GRANTS

- Assist nonprofits experiencing an unbudgeted, unexpected, and time-sensitive crisis.
- Do not exceed \$15,000.
- Can be requested between grant cycles.

APPLICATION PROCESS

- 1. Review The Erie Community Foundation's 2024 grant guidelines to confirm eligibility.
- 2. Contact Kelly Patterson, Community Impact Associate, at 814–454–0843, ext. 104 to schedule a pre-application meeting with the Community Impact Team.
- 3. Following the meeting, the applicant will receive an invitation link to apply.
- 4. If awarded funding, review, sign, and return the grant application. This will be done online.
- 5. Complete regular evaluations. Failure to do so will jeopardize future funding.

GRANT ELIGIBILITY

- The Erie Community Foundation awards grants to nonprofits defined as tax-exempt under Section 501(c)3 of the Internal Revenue code that are located within Erie County or demonstrate a sizable population within Erie County.
- Eligible nonprofits may receive funding once per grant cycle in a 12-month period.
- Applicants that do not have 501 (c)3 tax-exempt status may apply for a grant using a 501 (c)3 organization as its fiscal sponsor. A fiscal sponsor agreement must be submitted prior to submitting the grant application.
- In general, grants are not issued to: individuals, scholarship funds, fundraising events, deficit reduction, endowment campaigns, sectarian religious activities, and reimbursements for expenses already incurred.
